Off-licence

Sections 17 to 20, and 64 Sale and Supply of Alcohol Act 2012



Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Del Mundo Limited (the licensee) trading as "Del Mundo" is authorised to sell alcohol by remote sales to any person for consumption off the premises. The office is situated at 93 Marine Parade, Eastbourne, Lower Hutt.

Endorsement

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

Conditions

This licence is subject to the following conditions:

- No alcohol is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1:00pm on Anzac Day.
- Alcohol may be **sold** only on the following days and during the following hours: (b) At any time on any day
- (c) Alcohol may only be delivered between Monday to Sunday 6:00 am to 11:00 pm
- (d) No alcohol is to be delivered to the buyer (or to any other person on the buyer's behalf) at any time after 11:00 pm on any day and before 6:00 am the following day.
- (e) In the case of an order made using an internet site the Licensee must:
 - ask the prospective buyer to declare, by ticking an on-screen box, that he or she is 18 years of age or over (and, when a prospective receiver is involved, that the prospective receiver is also 18 years of age or over) -
 - 1. once when the prospective buyer first enters the internet site; and
 - again, immediately before the sale of any alcohol is completed;
 - refuse to sell alcohol to the prospective buyer unless, on both occasions, he or she declares that he or she is 18 years of age or over (and, where a prospective receiver is involved, also declares that the prospective receiver is 18 years of age or over).
- The Licensee must display on the internet site in a prominent place: the licence holders name, licence number, (e) expiry date and either a legible image of the licence, or a clearly identified link to such an image.
- The Licensee must ensure that there is printed on every receipt issued for alcohol sold remotely, the holder's (f) name and licence number, and the date on which the licence expires.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) either
 - until the close of the period for which it was last renewed; or i.
 - ii. if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- if an application for the renewal of the licence is duly made before the licence would otherwise expire, (b) either
 - until the close of the period of three years after the period for which it was last renewed; or i.
 - ii. if it has been renewed, until the close of the period of four years after the day it was issued.
