Off-licence – remote sales

Sections 17 to 20, and 64 Sale and Supply of Alcohol Act 2012



Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **Del Mundo Limited** (the **licensee**) trading as "**Del Mundo**" is authorised to sell alcohol by remote sale from, but not on, the premises situated at **93 Marine Parade, Eastbourne, Lower Hutt** and deliver it somewhere else.

Endorsement

Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else.

Conditions

This licence is subject to the following conditions:

- (a) No alcohol is to be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00pm on Anzac Day.
- (b) Alcohol may be sold only on the following days and during the following hours: For Sales Anytime on any day Deliveries Monday to Sunday 6.00am until 11.00pm
- (c) In the case of an order made by using an internet site the licensee must:
 - ask the prospective buyer to declare, by ticking an on-screen box, that they are 18 years of age or over (and when a prospective receiver is involved, that the prospective receiver is also 18 years of age or over) –
 - a. once when the prospective buyer first enters the internet site; and
 - b. again, immediately before the sale of any alcohol is completed
 - ii refuse to sell alcohol to the prospective buyer unless, on both occasions they declare that they are 18 years of age or over (and where a prospective receiver is involved, also declare that the prospective receiver is 18 years of age or over).
- (d) The Licensee must display on the internet site in a prominent place: the licence holders name, licence number, expiry date and either a legible image of the licence, or a clearly identified link to such an image.
- (e) The Licensee must ensure that there is printed on every receipt issued for alcohol sold remotely, the holder's name and licence number, and the date on which the licence expires.
- (f) All requirements pursuant to Section 59 of the Sale and Supply of Alcohol Act 2012, and Regulations 14 and 15 of the Sale and Supply of Alcohol Regulations 2013 must be met when alcohol is sold by remote sale.
- (g) During deliveries:
 - The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol delivery is not under 18 years of age, and that the receiver is not intoxicated.
 - ii. Alcohol will not be left unattended at the delivery address.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) either
 - i. until the close of the period for which it was last renewed; or
- ii. if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
 (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either
 - i. until the close of the period of three years after the period for which it was last renewed; or
 - ii. if it has been renewed, until the close of the period of four years after the day it was issued.
